



FRANCES R. WILLIS FRWSPCA PRIVACY POLICY REGARDING COLLECTION and RETENTION OF INFORMATION

The Dorchester Society for the Prevention of Cruelty to Animals d/b/a Frances R. Willis FRWSPCA (“the FRWSPCA”) may collect personal information from its website or through in-person or telephone communication. Personal information may include, without limitation, such information as name, address, telephone number, and email address. Any personal information collected by the FRWSPCA is done so only (1) with the consent of the person to whom the information relates and (2) when that person voluntarily provides such information to the FRWSPCA. Website users are not required to provide personal information to access or use www.summervillespca.com or any other domains, add-on domains, or sub-domains operated and/or owned by the FRWSPCA. The FRWSPCA may use any personal information you provide in order to contact you or provide you with the service or information you requested. By providing personal information to the FRWSPCA, you are authorizing the FRWSPCA to contact you by any means for which you provide contact information. The FRWSPCA may share any personal information you provide to the extent necessary to provide you with the service or information you requested. The FRWSPCA may also use this information to advise you about the FRWSPCA or to contact you regarding donations. The information may also be used by the FRWSPCA for its own market analysis or research. The FRWSPCA does not rent, trade, or sell your personal information. The FRWSPCA may retain this information for a minimum of three years, but in some cases, may retain the information for a longer period of time.

Additionally, through your use of the FRWSPCA’s websites, the FRWSPCA may also collect information that is typically or generally recorded through the use of websites, including, without limitation, your IP address and statistical information such as number of visitors and what portions of our site you visited. This type of information will only be used to evaluate the operation of the website, the material on the website, to diagnose and correct technical problems with the website or our server, and/or evaluate and improve the quality of the website and its content. This information is not used for personal identification of users. Neither www.summervillespca.com nor any other domains, add-on domains, or sub-domains operated and/or owned by the FRWSPCA utilizes permanent Cookies.

The FRWSPCA does not intentionally collect personal information about children under the age of 13.

Any disclosure or use of information collected from you by the FRWSPCA which is different from that described above will be made by the FRWSPCA only as may be required by law.

The use of the FRWSPCA’s websites shall be governed by the laws of the United States and/or the State of South Carolina without giving effect to conflicts of laws provisions of the state or country of user’s residence. Additionally, venue for any controversy or dispute which may arise between user and the FRWSPCA shall be in the South Carolina Court of Common Pleas, First Judicial Circuit, Dorchester County, South Carolina regardless of user’s state or country of residence.
